**FORMAL DOCUMENTS RELATED TO THE ULTRA-SHORT

Non-profit tax-exempt organizations are required to make certain documents available to the public. Those documents are: i) Form 990 and appropriate schedules, and ii) Form 1023. These documents are available upon request from the current USRPTIA Treasurer, Brent Rushall.

Because there are costs pertaining to these documents (e.g., reproduction, mailing, etc.) requests for copies will need to be accompanied by a cheque made payable to USRPTIA.

**Form 990** is the annual tax return for the USRPTIA.

- Form 990 and Schedule D for 2016 comprise 16 pages. For copying and secure postage a request should be accompanied by a cheque for \$25.00.

**Form 1023** is that application for federal tax-exemption for the USRPTIA.

- Form 1023 and attachments comprise 73 pages. For copying and secure postage a request for a copy should be accompanied by a cheque for \$40.00.
